#### (1) Monetary Unit

The accounting records of the external resources are kept in dollars of the United States of America and the summary of revenue and expenditures is expressed in such currency. Transactions made in colones (¢), the monetary unit of the Republic of Costa Rica, are translated into US dollars for accounting purposes at the exchange rate of ¢8.54 to \$1.00.

### (2) Objetives of Funds Contributed by External Resources

External resources consist of funds assigned by international organisms, private enterprises and third parties, with the purpose of developing investigation projects and cover personnel expenses of Centro Agronómico Tropical de Investigación y Enseñanza.

## (3) Administration of the Execution of External Resources

External resources provided for the execution of special projects are managed by Centro Agronómico Tropical de Investigación y Enseñanza, a non-profit civil association, with its own legal representation, which purpose is to execute, promote and stimulate investigation and teaching in the fields of agriculture, animal science and related areas.
